

If you have Missouri Business Income, you can get a 50% credit on your Missouri business tax by donating to CJM. We have credits available through the **Neighborhood** Assistance Program (NAP). The credits are in addition to other deductions. Get more information here or by contacting info@cjmstlouis.org.

A qualified charitable distribution (QCD) is a donation from your retirement account and can be made after age 70½ even if you are not subject to Required Minimum Distributions. A QCN is not subject to ordinary federal income taxes – the amount is simply excluded from your taxable income. Consult a qualified tax advisor to determine if a QCD would be beneficial for you.
